Residents expressed their ongoing concerns regarding the planned clearance work due to be undertaken along York Lane by ERYC, along with the cost implications involved and the lack of support from the Parish Council.

3978 TO RECEIVE A REPORT FROM THE POLICE AND THE LOCAL WARD COUNCILLOR.

A report was received via email from local PSCO listing recent crime statistics in the area.

Cllr Gary McMaster informed the Parish Council of issues concerning youths in the area and that the anti-social team at Humberside Police has been made aware. The Chairman informed the Parish Council that a meeting has been arranged with the Assistant Head at Wolfreton School on Thursday 20th December.

Cllr McMaster confirmed that no application has as yet been submitted in connection with the Well Lane site/development; and therefore cannot move forward with any objections at this stage. He is aware of the concerns regarding traffic and congestion particularly on the "Papas" roundabout. He will inform us of any further developments.

He is still waiting for further information regarding the potential Willerby/Swanland Surgery merger and the proposed new location.

The Parish Council agreed that they cannot move forward with any objections until an application has been submitted. It was agreed that a meeting with the Willerby Action Group should be arranged if/when an application is submitted.

Wolfreton School has been contacted regarding issues of both pupil cycle safety and smoking –
 The Chairman confirmed that a meeting had been arranged and was to take place at the school on 20th December 2018.

 undertake clearance work along York Lane The Parish Council agreed to attend a meeting to
 be arranged by the residents with ERYC, the Ramblers Association and the residents
 themselves.
- Noisy vehicles on Main Street reported by local resident PSCO confirmed that they are currently looking into cars "meeting" up at Willerby Hill Car Park on an evening **Noted**
- Steven Murray at ERYC has confirmed he has ordered three new bollards to replace the damaged ones outside the opticians in the square. He also confirmed that new additional bollards have been ordered and will be installed to prevent vehicles reversing onto the pavement It was confirmed that these have now been installed. However it was noted that a similar issue was now occurring on the opposite side of the square outside Boots. Clerk to contact Boots and ERYC.
- Clerk has added Parish Council FAQ/about us page to website to promote awareness of who the Parish Council are and what they do **Noted**
- Willerby Parish Council Community Award to be presented by the Chairman to pupil at Carr Lane Primary School in their assembly on the 14th December **Noted**
- Chairman expressed thanks to Cllr Foote and Cllr Knott for all of their hard work and efforts with the Festive lights.
- A pedestrian barrier on Beverley Road, Willerby was reported as damaged. Clerk to inform ERYC.
