5066 TO RECEIVE A REPORT FROM THE POLICE AND THE LOCAL WARD COUNCILLOR.

Ward Cllr Ben weeks was welcomed by the Chairman and provided the Parish Council with an update to the current Biowise situation. He confirmed that a higher number of complaints to the Environment Agency have been made this year and that an audit by the Environment Agency has been completed with the results still pending.
