5356 TO RECEIVE A REPORT FROM THE POLICE AND THE LOCAL WARD COUNCILLOR.

TO ARRANGE PLACEMENT OF POPPY WREATHS ON 2 X REMEMBRANCE BENCHES (WILLERBY SQUARE & LADYSMITH ROAD) AND TO DISCUSS/ARRANGE REMEMBRANCE DECORATION OF THE HOP-POLE ROUNDABOUT.

It was confirmed that Cllrs T Williams, G Crawforth & P Graham would attend the remembrance ceremony at the War Memorial on November 14th. It was agreed that Cllr T Williams would arrange placement of poppy wreaths on the two village remembrance benches and decoration of the Hop-pole roundabout. Parish Clerk to contact Royal British Legion to confirm attendees and to request loan of large poppies for roundabout display.

5364. CLLR R MCKINNON & CLLR P MARSHALL TO PROVIDE UPDATE WITH REGARDS TO CHRISTMAS EVENT. TO CONSIDER THE FESTIVE DECORATION OF THE PARKWAY ROUNDABOUT.

The Parish Clerk confirmed that the Christmas tree had been ordered from Lite Ltd with an approximate delivery date of between 15th -20th November (exact date TBC) and that Cllr P Marshall & Cllr R Mckinnon have agreed to be on site to meet delivery. Parish Clerk informed the Parish Council that the East Riding Brass Band have confirmed that they will be able to attend and perform between 18:15-18:45, and suggested an event start time of 18:00. Cllr L Telford to check if timings are compatible with local children's groups. Project to be added to November's agenda for update from Cllr P Marshall & Cllr R McKinnon. The Parish Council **resolved** that the festive decoration of the Parkway roundabout by an external company should be included in the 2022-2023 budget. Parish Clerk to apply for 2021 Festive Lights permit from East Riding Council for the Hop-pole and Willerby Square roundabouts.
