 - Cllr Saribel liaised with PC Ollie Turner and ERYC. ERYC conducted a site visit, and it was concluded that no further action would be taken.
- Parking & Landscape/Maintenance issues on the Oval/Chestnut Ave, Willerby – Landscape & Maintenance reported to ERYC. Advised resident to contact ERYC directly regarding parking & provided ERYC contact details.
 - Maintenance/repainting of older style lampposts on the Oval, Willerby was added to ERYC's Summer Maintenance schedule. A site visit was conducted by ERYC Grounds team and the resident was spoken to directly.
- Bus Stop Maintenance – reported to ERYC & EYMS.
